
Hot Off the Press

in the following formats: eBook, trade paperback, and large print. Here's what some early readers have to say:



What's Neil Reading?


There's a very good reason why Joseph Finder is among my favorite thriller authors. House On Fire epitomizes everything that makes his books must reads for me. Ex-soldier turned private detective Nick Heller is a multifaceted character you can't help but root for, the supporting cast is outstanding, and—the mark of the true proeven antagonists are well fleshed out. The author keeps us guessing

about who may be or may not be Nick's allies as he is pulled deeper and deeper into the myriad disfunctions of the Kimball family. The plot of the story, which centers around the opioid epidemic and the companies that fuel it, is a twisty, turny delight. The exhaustive research Finder puts into his novels shines through here, making House on Fire not only a highly enjoyable read, but also a primer on the subject at the heart of the story. The resolution packs a punch and a couple of late surprises I didn't see coming. Finder has outdone himself yet again

Here's this month's question and answer:

Q: How do you balance plot and character? Which is more important?

A: This is an interesting craft question in two parts, and there are probably as many answers as there are authors. Here's my take, which I offer from the perspective of a thriller writer. I consider character to be the single most important aspect of writing. Unless I

care about the people in the story, what happens to them doesn't much matter to me. As for balance, just because we care about a character doesn't mean we're going to stick with them through 400 pages of navel gazing. For my money, a good book includes compelling characters navigating their way through a propulsive tale with plenty of obstacles to overcome, huge dollops of uncertainty at every turn, and all with a universal theme underpinning the story. Now, I may not be able to actually do that myself, but it's what I like to read! 2
